Lyman Harbor 2018 Marina Rules

- 1. It is unlawful to transfer gasoline from one container to another container while in the Marina.
- 2. All electrical cords must be a marine type U.L. approved cord (NO EXTENSION CORDS ALLOWED ON THE DOCK.) Cords are not allowed to cross the top of walkways or finger piers. No alternations or modifications to any electrical outlet used for servicing a vessel with shore power shall be made. Plugs must match the receptacle used.
- 3. No using power from any other dock other than your own (violation will cause immediate permanent ejection from Lyman Harbor).
- 4. No major repairs, other than minor repairs and routine maintenance, shall be performed on any vessel in the marina (violation will cause immediate permanent ejection from Lyman Harbor).
- 5. The marina is for recreational boating only.
- 6. Docking of vessel will be permitted only in designated areas as assigned by Lyman Harbor.
- 7. NO WAKE IN MARINA AREA
- 8. Vessel owners are solely responsible for proper docking, mooring, and securing their vessels at all times to prevent vandalism, theft, & damage.
- 9. Vessel owners are responsible for securing their vessels and equipment on board to prevent vandalism and theft.
- 10. Lyman Harbor is not liable for any damage or loss to any vessel due to theft, vandalism, fire, act of God, or other causes
- 11. Children under twelve (12) years of age are not permitted on the docks without a parent or responsible adult in attendance. NON-SWIMMERS AND YOUNG CHILDREN ARE REQUESTED TO WEAR LIFE JACKETS WHEN ON DOCKS OR WATERCRAFT DECKS.
- 12. Boat slips are NOT transferable.
- 13. Boat slips are for sole use of renter's boat.
- 14. Lyman Harbor has the assignment of seasonal boat slips when not occupied by renter's boat vessel.
- 15. When possible, seasonal boaters are asked to notify Lyman Harbor when the slip is going to be "free" overnight.
- 16. Owners are responsible for their guests, and must make them aware of marina rules. If your guests break our rules you will lose your boat slip with no refund.
- 17. For the safety of all, no running, swimming or water fights are allowed on the dock area.
- 18. Bicycles are not allowed on any piers or floating dock walkways.
- 19. No commercial activity shall be conducted at Lyman Harbor, without the written approval of Lyman Harbor. Commercial activities include, but are not limited to, rental or leasing boats, chartering of boats, and use of the marina address, use of a number of a telephone or facsimile on a boat in any advertising, brochure, letterhead, business card, or other

commercial document. No advertising or soliciting is permitted in the marina. The display of "FOR SALE" signs on a vessel is not permitted without approval of Lyman Harbor. Initial:

- 20. Only suggestions should be presented in writing to Lyman Harbor. Lyman Harbor is an entertainment complex and our main goa) is to entertain. Lyman Harbor would like only to have "carefree" boaters!
- 21. Only vessels in good and seaworthy condition will be admitted.
- 22. Each person assigned a dock space shall at all times provide Lyman Harbor office his/her current telephone number and an emergency telephone number where he/she may be reached, or messages received at all times.
- 23. Fires of any nature on boats, docks, parking spaces or in the marina shall be prohibited.
- 24. Altering any Lyman Harbor equipment or property including the floating docks with prior approval of the office is prohibited.
- 25. No fireworks shall be permitted at Lyman Harbor.
- 26. No unlicensed boats, including remote controlled floating devices, shall be permitted in the marina area.
- 27. The boat owner, prior to leaving the marina, should remove alt fish carcass, bait, trash, debris, etc. The boat owner shall NOT use on site trash drums to dispose of unusable fish and bait
- 28. Swimming, diving, and fishing are not permitted from the docks or finger piers. No minnow nets are allowed in the marina. Bait holding pens and traps must be limited to the boat owner's licensed space ONLY.
- 29. Entering onto or trespassing upon any vessel or space reserved or occupied by any other person without the expressed permission of the boat owner or the Marina is strictly prohibited
- 30. Such intrusion or trespass shall be grounds for IMMEDIATE EVICTION from the property of Lyman Harbor with no refund, at the sole discretion of Lyman Harbor management staff. 29. Renter agrees to have adequate boat insurance for complete marine coverage including liability, loss and damage (violation will cause immediate permanent ejection from Lyman Harbor).
- 31. The customer agrees that the slip rental is at his/her own risk. Lyman Harbor is not responsible for any damage or injuries caused by theft, wake, flood, fire, hurricane or any act of God. The customer shall hold the marina harmless in the event of such an occurrence. The customer will be held responsible for damage they may cause to other boats in the marina or to the structures or facilities thereof.
- 32. No weapons of any kind (violation will cause immediate ejection from Lyman Harbor with no refund).
- 33. No illegal activity of any kind will be tolerated (violation will cause immediate permanent ejection from Lyman Harbor). 33. No unsafe behavior of any kind will be tolerated (violation will cause immediate permanent ejection from Lyman Harbor).
- 34. 1st Violation Warning. 2nd Violation \$50 Fine. 3rd Violation Termination of Agreement.
- 35. These marina rules are subject to change and may be amended from time to time as deemed necessary by Lyman Harbor.
